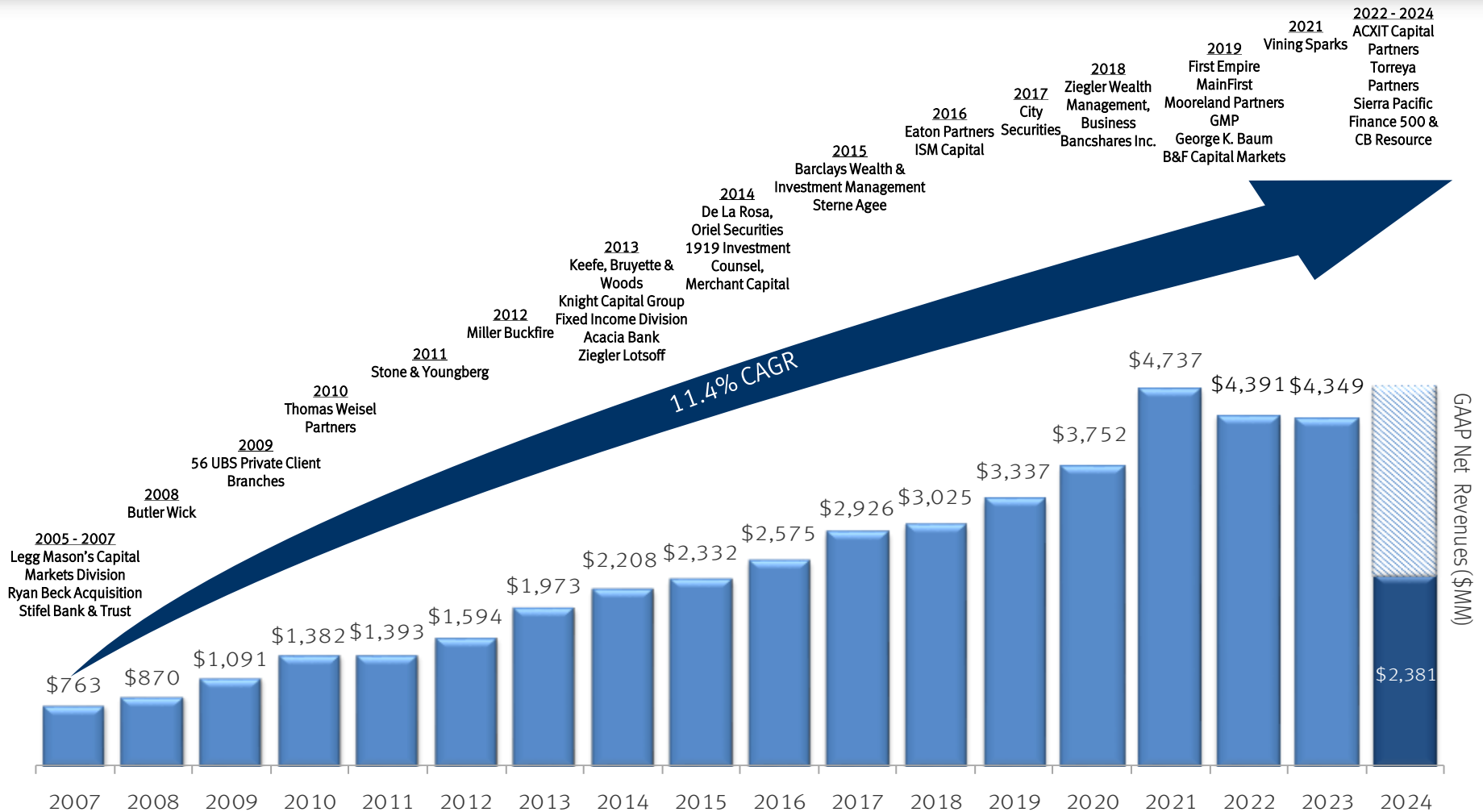

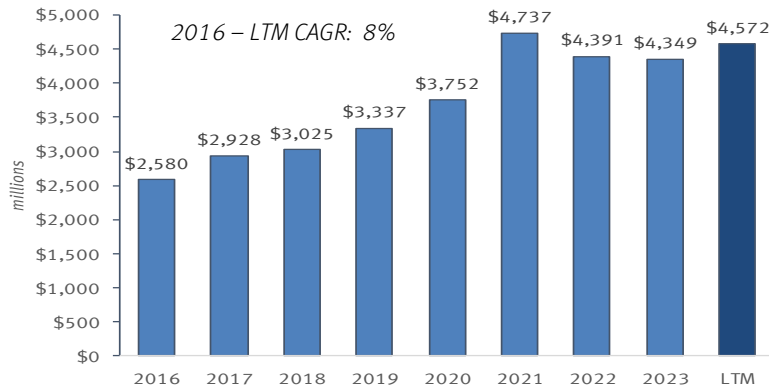
A History of Organic Growth & Acquisitions



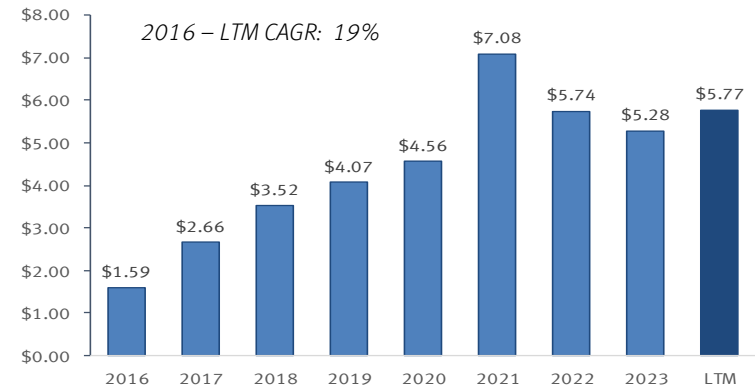

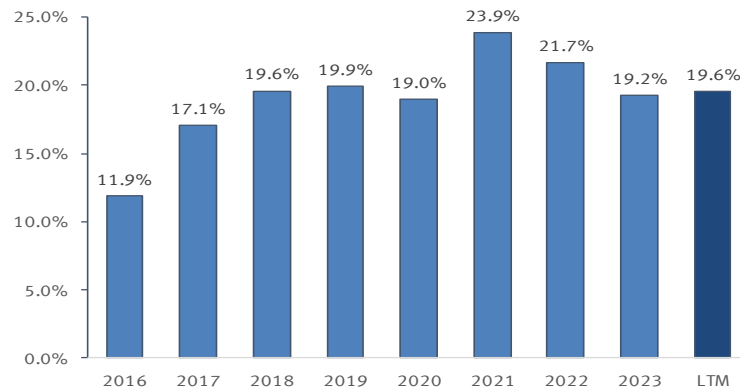
Net Revenue¹



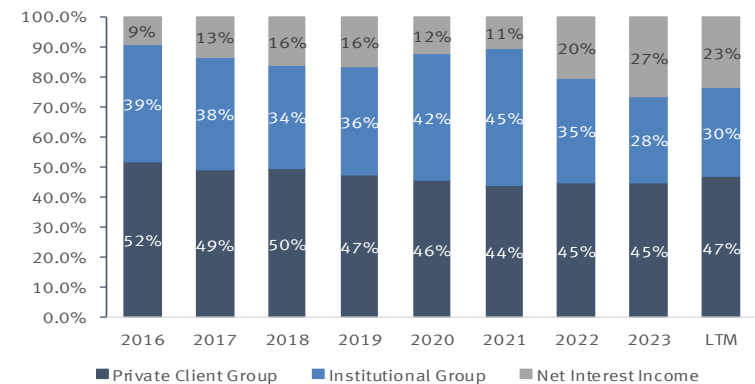
Earnings Per Share^{1,2,3}

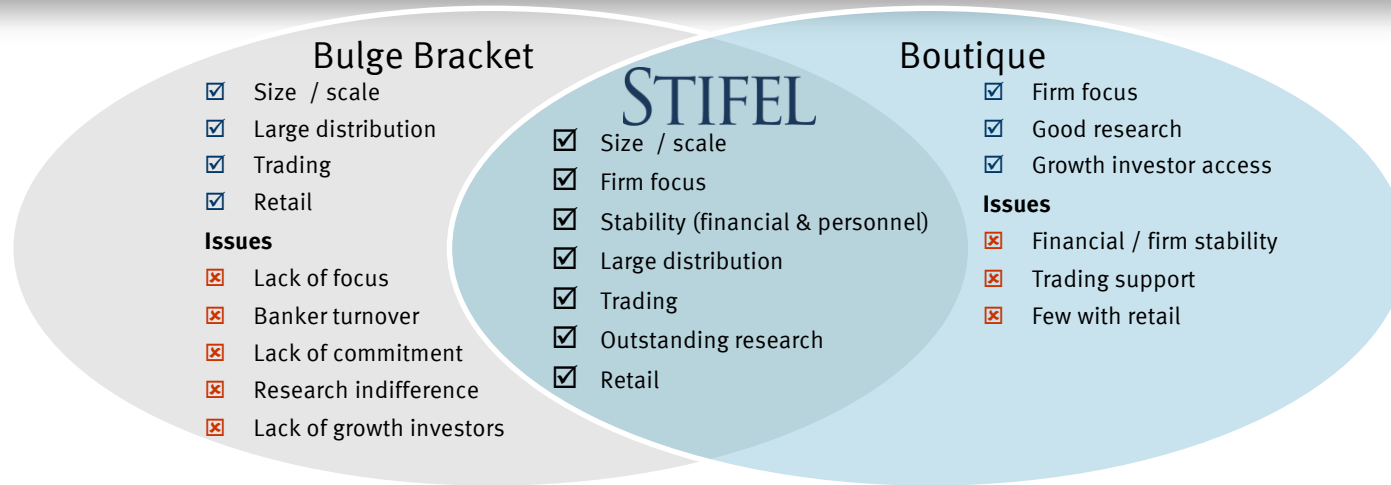

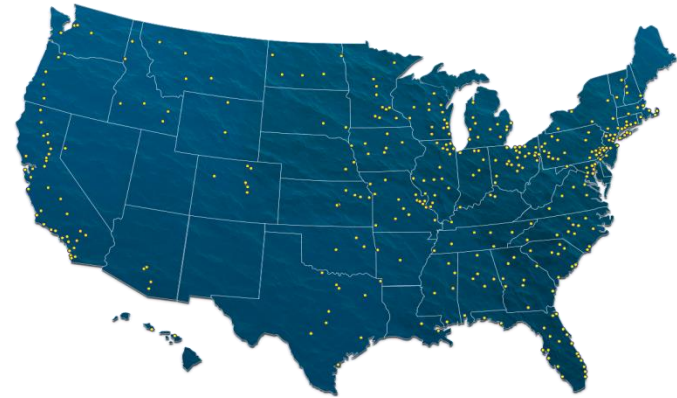

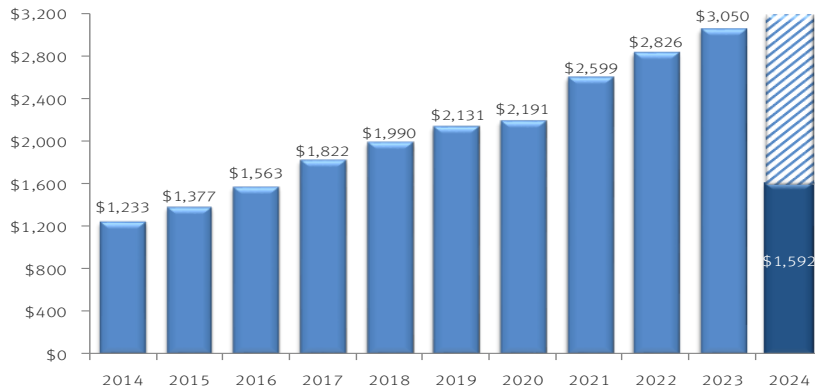

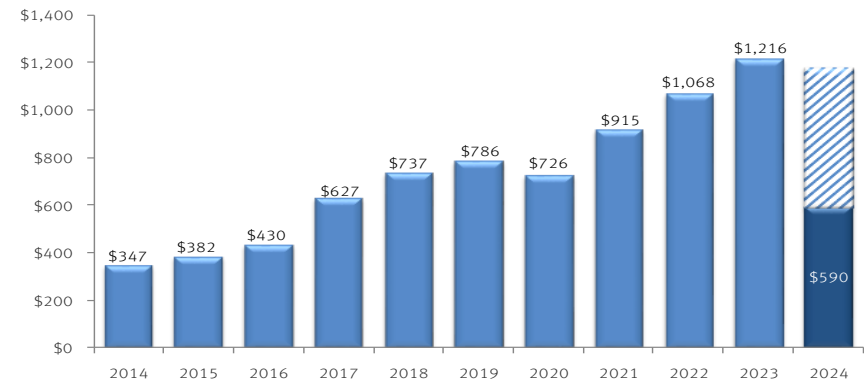
National Presence

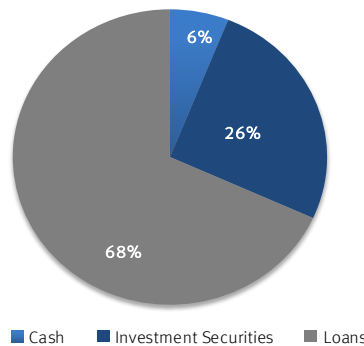

- Maintain high levels of liquidity

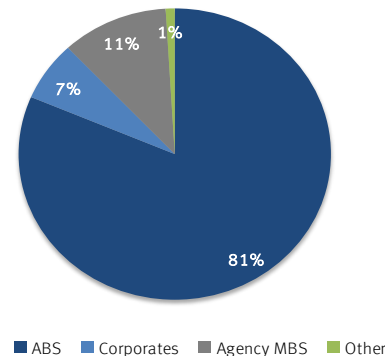

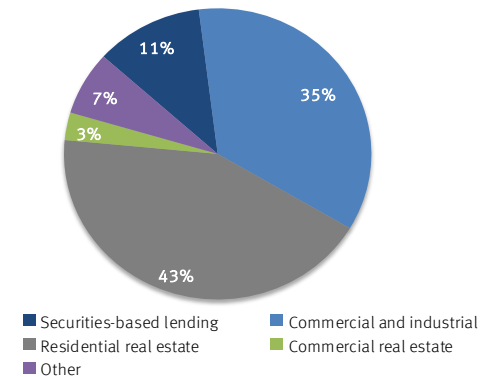
Interest Earning Assets

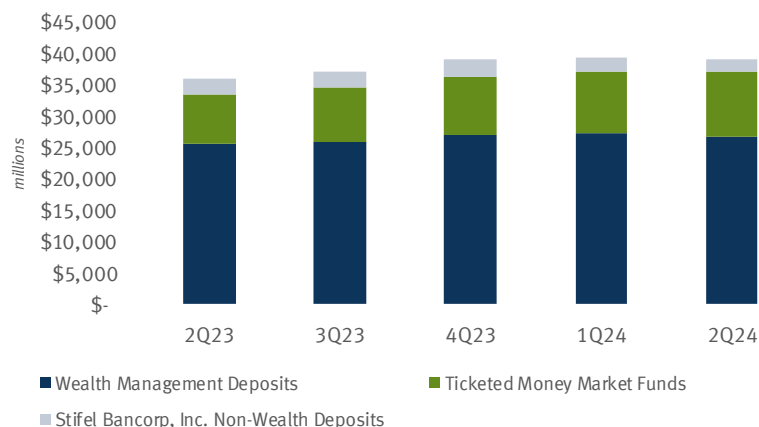

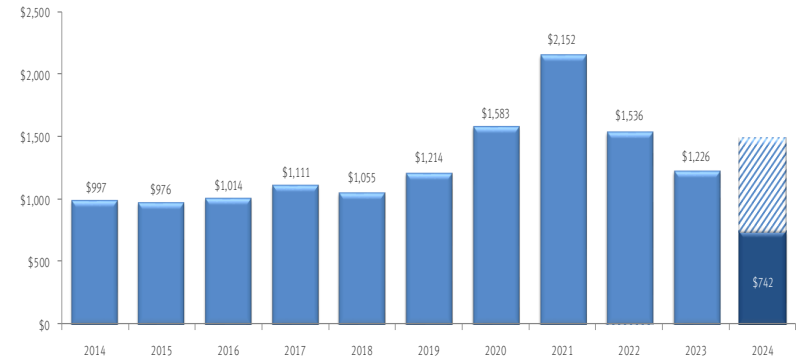

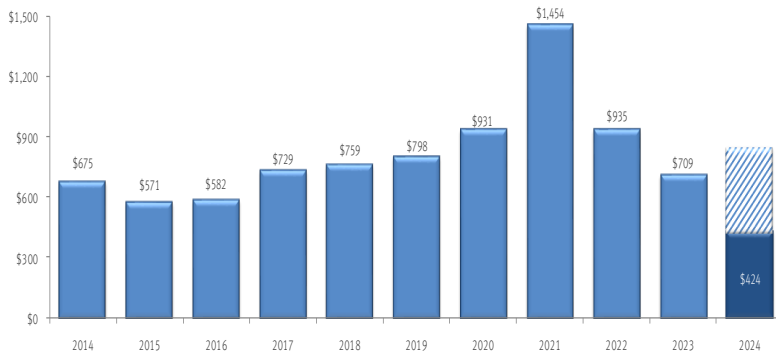

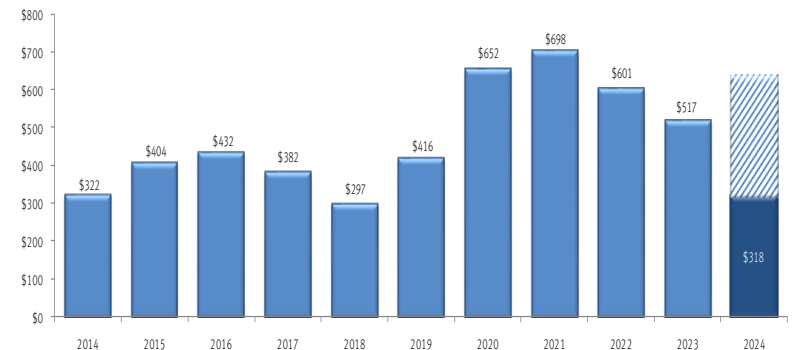
Net Revenues (\$MM)^{2,3}
